MARKET GUIDELINES

Please sign and date this form below as part of the application process. Each of us as vendors must uphold these guidelines and maintain an open dialogue for a peaceful, fun, and harmonious season together.

- I agree to respect the fact that the primary purpose of the Town of West Rutland Farmers' Market is to provide local food items to members of our community. I will not use the market as a means to sell any other goods, services, political or religious views not in keeping with the local, agricultural feel of the market.
- I agree, for the harmony of the market, to be in my stall by 3:45 pm and to have my vehicle safely parked away from prime parking at the time the market begins at 4:00 pm.
- I agree that I must take into consideration how my umbrellas and the positioning of my tables and signage affect the overall aesthetic and safety of the market and my neighbors.
- I agree to keep my stall up and occupied until 7 pm and not to begin breaking down before the close of market at 7 pm, unless I am "sold out."
- I agree to take responsibility for my children when they are brought to the market.
- I agree to leave my pets at home.
- I agree to give at least 24 hr. notice if I will not be attending a scheduled market.
- I agree that the vehicles belonging to my employees and any secondary vehicles should be parked away from the Farmers Market and not to park in the vicinity of the Town Hall Green. I will keep in mind that parking is at a premium and should be reserved for market customers.
- I understand that the market has a "carry in, carry out" policy for all trash accumulated during the market. I will not put trash in the town trash cans, damage city landscaping, nor leave any trash behind. I will not dispose of water that contains coffee, bleach, food stuffs, ice, or coals into the drains or the grass on or around the Town Hall Green.
- I agree to allow any photographs taken of me or my booth to be used in any and all Town of West Rutland Farmers' Market marketing campaigns.
- I understand it is my responsibility to read and abide by the Vermont State Regulations for Farmers' Market Vendors (which can be found at www.state.vt.us/agric)

*** Vendors wishing to sell meat, cheese, milk/prepared/value added foods, and plants must meet and comply with all appropriate state and federal laws, hold valid and current licensing, permits, and insurance, and provide the Town of West Rutland Farmers' Market with copies of those permits prior to the first market.*

I have read and agree to abide by all Town of West Rutland Farmers' Market guidelines, as well as to comply by all federal and state laws pertaining to selling at a farmers' market. I agree to cooperate with other vendors to maintain a harmonious and community-minded market.
